Are there services covered before you meet your <u>deductible</u>?	<p>Yes. <p>What is the <u>out-of-pocket limit</u> for this <u>plan</u>?</p>	<p>After network deductible has been met, Penn State has a network coinsurance maximum to meet of \$1,250 individual/\$2,500 family (<u>excludes deductible</u>). This is a <u>network out-of-pocket limit</u> of \$1,750 individual/\$3,500 family (<u>includes deductible+coinsurance maximum</u>), up to a total maximum out-of-pocket of \$9,100 individual/\$18,200 family.</p> <p>After out-of-network deductible has been met, Penn State has an out-of-network coinsurance maximum to meet of \$2,500 individual/\$5,000 family (<u>excludes deductible</u>). This is an <u>out-of-network out-of-pocket limit</u> of \$3,500 individual/\$7,000 family (<u>includes deductible + coinsurance maximum</u>).</p>	<p>The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. Does this plan provide Minimum Essential Coverage? **Yes**

Minimum Essential Coverage generally includes plans, health insurance available through the Marketplace or other individual market policies, Medicare, Medicaid, CHIP, TRICARE, and certain other coverage. If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.

Does this plan meet the Minimum Value Standards? **Yes**

If your plan doesn't meet the Minimum Value Standards, you may be eligible for a premium tax credit to help you pay for a plan through the Marketplace.

The Claims Administrator/Insurer will not deny or limit coverage for a specific health service related to gender transition if such denial or limitation results in discriminating against a transgender individual. The Claims Administrator/Insurer:
