What is the overall <a href="#">deductible</a> ?	<b>\$500</b> individual/ <b>\$1,000</b> family – <a href="#">In-network</a> <b>\$1,000</b> individual/ <b>\$2,000</b> family – <a href="#">Out-of-network</a>  The <a href="#">deductible</a> does not apply to preventive services. Coinsurance amounts do not apply toward the <a href="#">deductible</a> .	You must pay all the costs up to the <a href="#">deductible</a> amount before this plan begins to pay for covered services you use. Check your policy or plan document to see when the <a href="#">deductible</a> starts over (usually, but not always, January 1st). Are there services covered before you meet your <a href="#">deductible</a> ?	<b>Yes.</b> Preventive services, office visits, emergency room services, urgent care, outpatient mental health, outpatient substance abuse and rehabilitation services. **Your Rights to Continue Coverage:**

If you lose coverage under the plan, then, depending upon the circumstances, Federal and State laws may provide protections that allow you to keep health coverage. Any such rights may be limited in duration and will require you to pay a **premium**, which may be significantly higher than the premium you pay while covered under the plan.
